All the constitution members have given the instructions that to follow the AICTE guidelines/ Grievances may include the following complaints of the aggrieved students namely-

- (i) Making admission contrary to merit determined in accordance with the declared admission policy of the institute.
- (ii) Irregularity in the admission process adopted by the institute.
- (iii) Refusing admission in accordance with the declared admission policy of the institute
- (iv) Withhold or refuse to return any document in the form of certificate or degree, diploma or any other award or other documents deposited with it by a person for the purpose of seeking admission in such institution, with a view to induce or compel such person does not intend to pursue.
- (v) Demand of money in excess of that specified in the declared admission policy or approved by the competent authority to be charged by such institution:
- (vi) Breach of the policy of reservation in admission as may be applicable:
- (vii) Complaints of alleged discrimination by students from Scheduled Caste, Scheduled Tribes, OBC, Women , Minority or disabled categories.
- (viii) Nonpayment or delay in the payment of scholarships to any students that such institute is committed, under the conditions imposed by AICTE, or by any other authority.
- (ix) Delay in conduct of examinations or declaration of results beyond that specified in the academic calendar.
- (x) On provision of students amenities as may have been promised or required to be provided by the institution.:
- (xi) Denial of quality education as promised at the time of admission or required to be provided:
- (xii) Non transparent or unfair evaluation practices:
- (xiii) Harassment and victimization of students including sexual harassment : and
- (xiv) Refund of fees on withdrawal of admission as per the AICTE instructions from time to time.
